Activity Bus Driver		Two times the Alaska minimum wage**

*Pursuant to [Alaska Statute 23.10.065\(a\)](#), the Alaska minimum wage is to be adjusted annually for inflation using the Consumer Price Index (CPI) for the proceeding January-December calendar year. The Alaska State minimum wage increased to \$9.89 effective January 1, 2019.

**Pursuant to [Alaska Statute 23.10.065\(b\)](#), persons employed as a school bus driver shall receive at least two times the Alaska minimum wage.
