



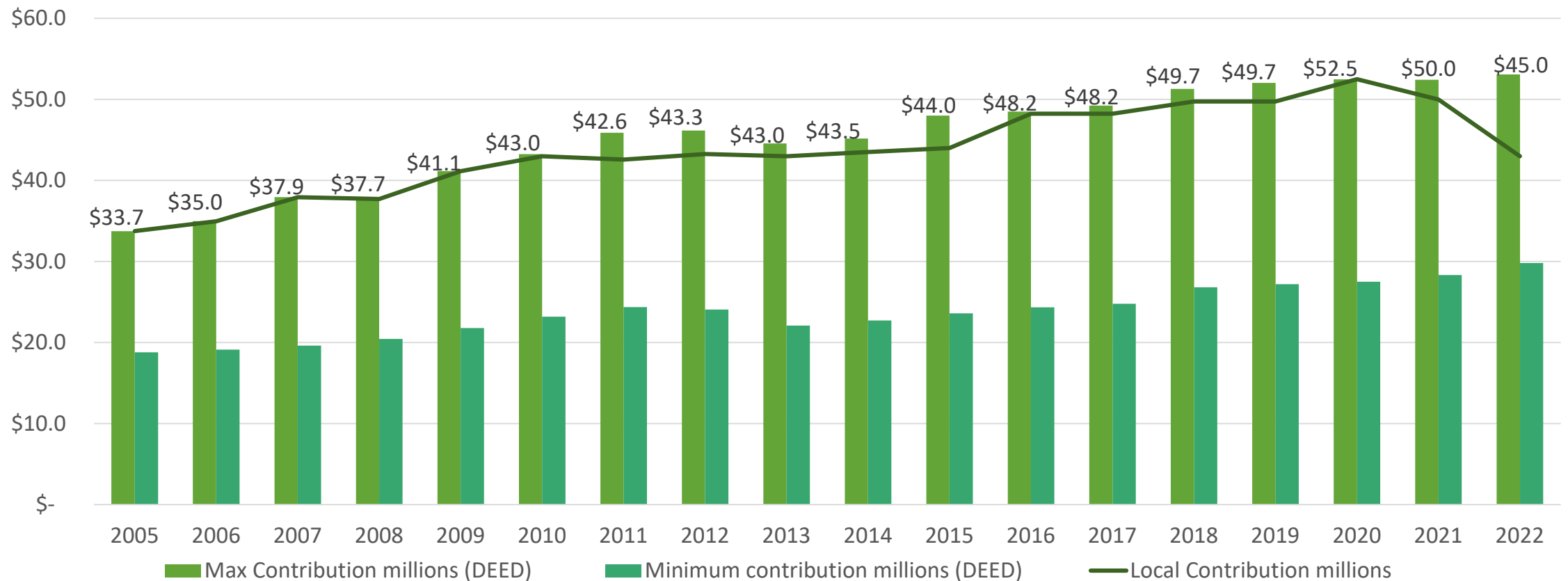

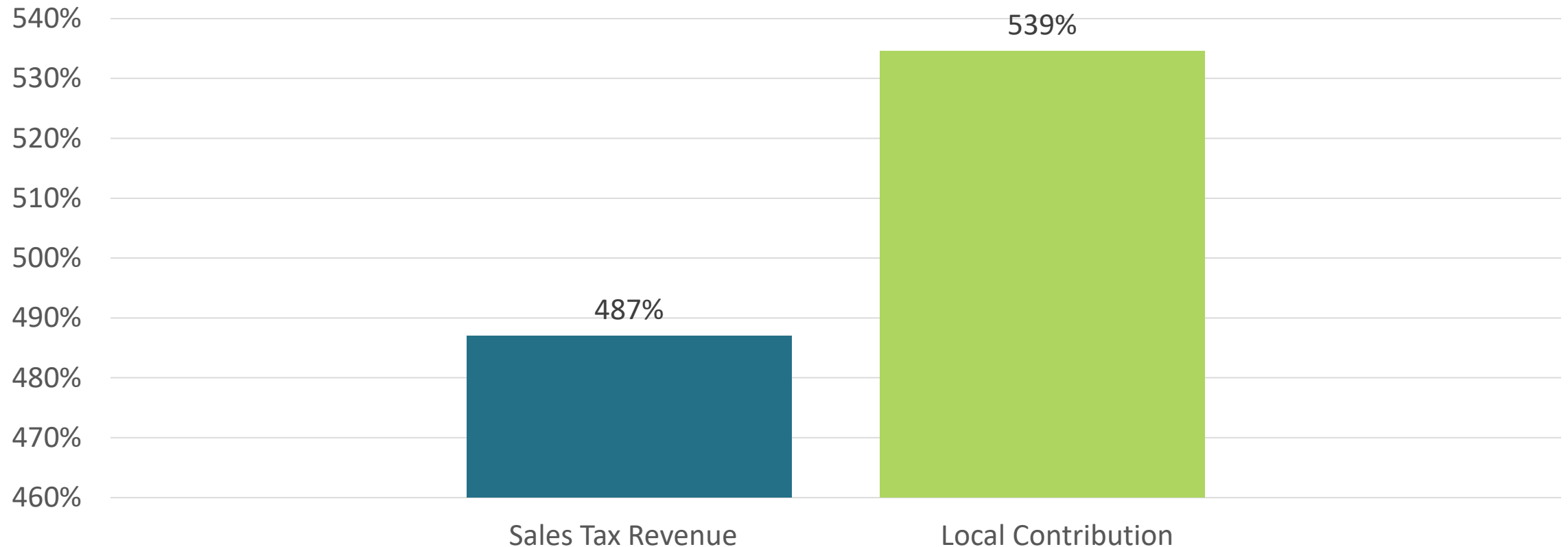

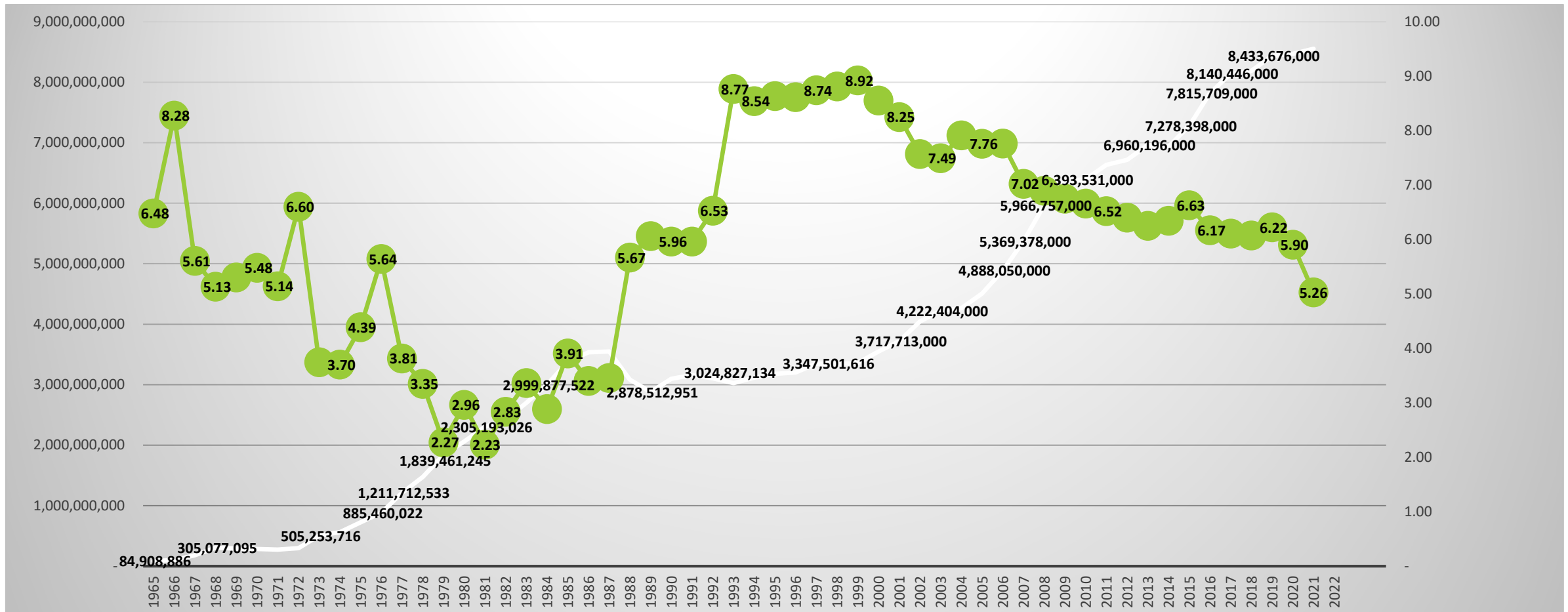
# Local Contribution Compared to Required Minimum and Maximum Allowable Contribution - Fiscal Years 2005 to 2022



# Historical – Percentage Change Over Year for Both Sales Tax Revenues and Local Contributions – FY1965 to FY2022

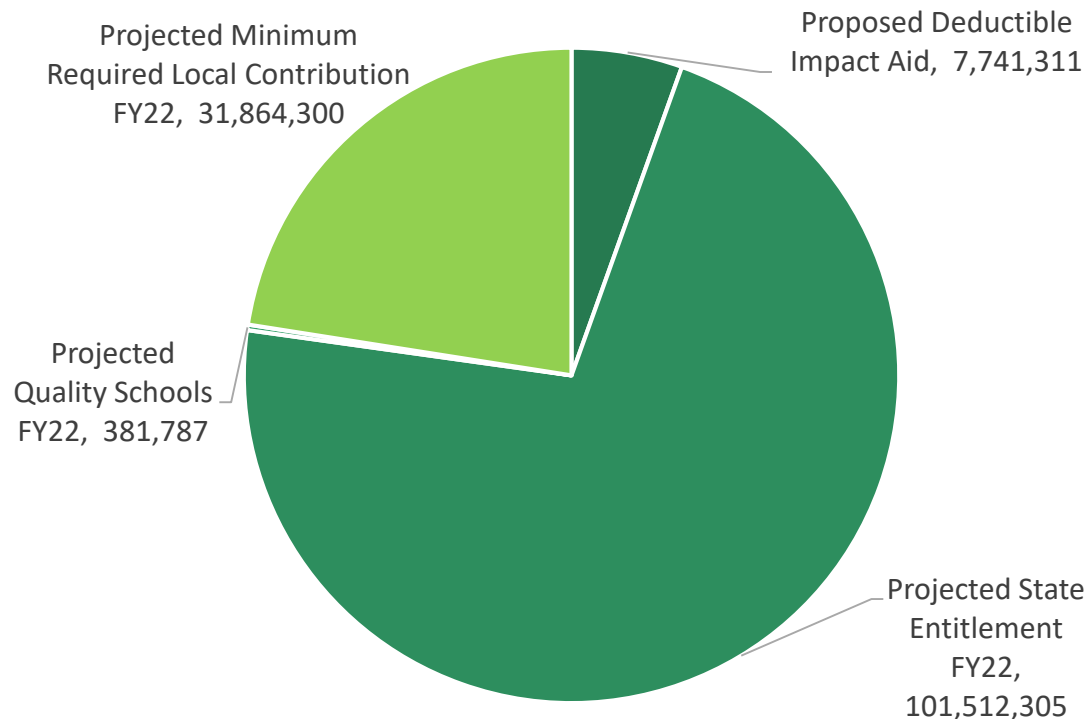


# Historical Mill Rate Equivalent of Local Contribution and Taxable Assessed Values – Fiscal Years 1965 to 2022

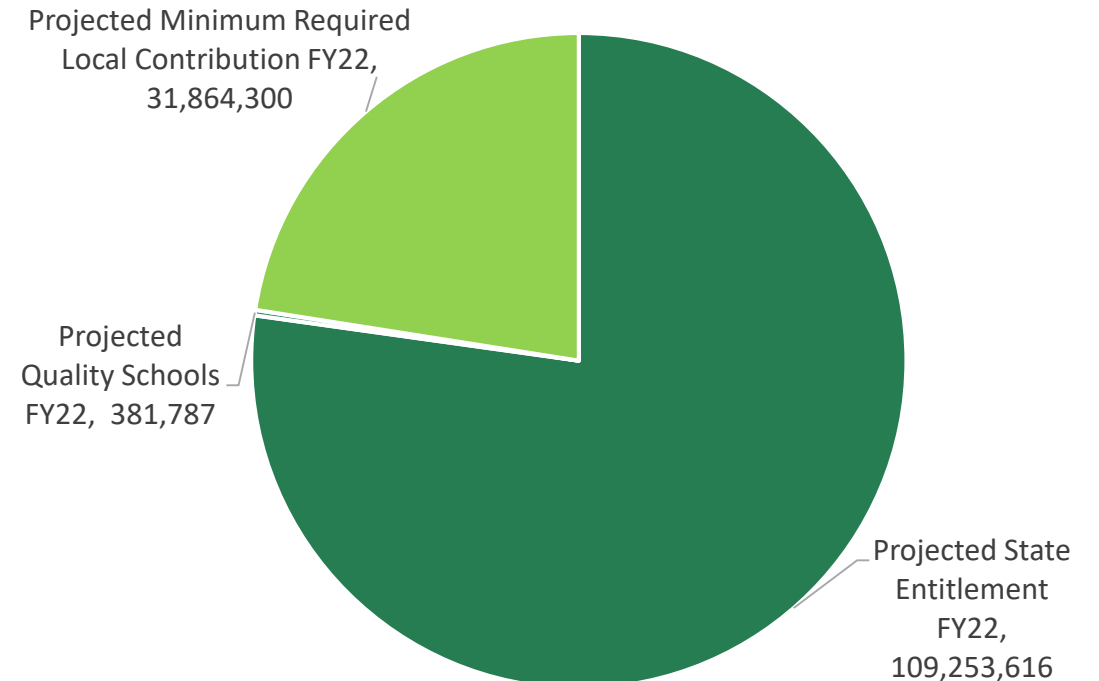


# Local Contribution and Impact Aid Relationship

## School District with Impact Aid



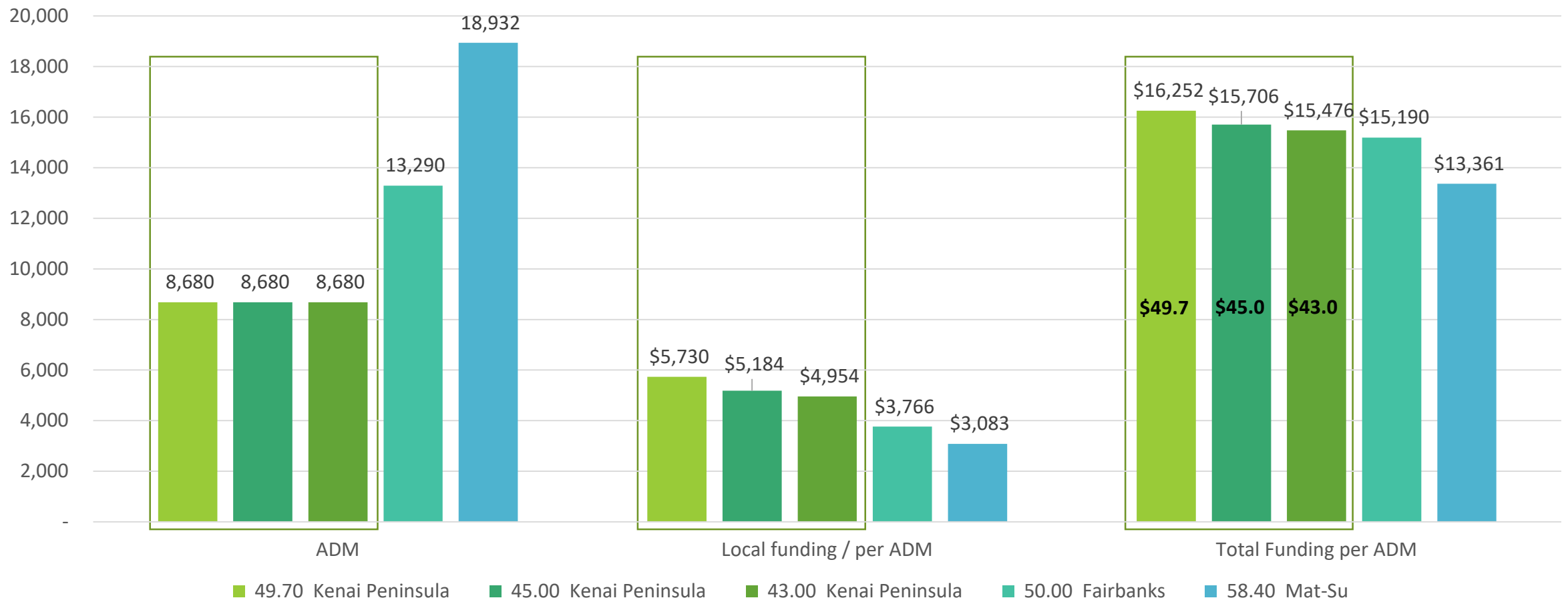
## School District Without Impact Aid
