Attached please find the Handbook changes for the following:

Middle School Handbook Changes

1. *Page 12, IX. ACTIVITY RULES, BASKETBALL Section C.*
Language addition noted in [blue](#).
....
3. Zones are still allowed, but zones cannot extend beyond the 3-point area. Collapsing man to man defense is permitted. [Man to Man defense is strongly encouraged](#).
2. *Page 37, XVI. ACTIVITY RULES, WRESTLING (Boys [and Girls](#)): Section B, Item 1 & 2; Section C.; Section D.; Section E, items 2, 5 & 6*
See attached. Language changes and updates to MS Wrestling. Adding Girls wrestling classifications and updating boys classification. Various language updates as noted.
3. *Page 53, APPENDIX D, Team/Staffing Guidelines.* Add 2nd Assistant Coach for Wrestling at 30+ participants. This option provides better coverage with the increased participation, especially in Girls Wrestling.

High School Handbook Changes

1. *Page 17, V. PARTICIPATION GUIDELINES FOR ACTIVITIES, Section D, Item 3* [Esports participation fees shall be paid through PlayVS](#).
Language change for the addition of Esports for high school.

2. *Page 21, VI. GENERAL ACTIVITIES POLICIES FOR THE KPBSD, Section I, Item 3 (7) Esports*
 - a. *Eligibility. Participants must meet KPSAA and ASAA eligibility requirements. A Physical Examination, Concussion Information Form and Sudden Cardiac Arrest Form are not required. Participant names must be entered in the School Activities Reports System (SARS).*
 - b. *Season. Fall Season and Spring Season dates will be determined by ASAA.*
 - c. *Rules. PlayVS will coordinate the program. Schools may only have one varsity level team for each game. Schools may have multiple sub-varsity teams. Sub-varsity teams will not advance into the playoffs. All other game rules will fall under ASAA guidelines.*

2. *Page 21 - Appendix D, Team/Staffing Guidelines: Esports, Minimum for Team/Coach is 4. Wrestling 2nd Assistant Coach when participant numbers reach 30+ athletes.*
