**AGREEMENT TO FOLLOW RULES
RELEASE OF LIABILITY, HOLD HARMLESS AGREEMENT, AND
COVENANT NOT TO SUE**

KPBSD LOT CAMPING RULES:

1. NO ALCOHOL, MARIJUANA OR WEAPONS ALLOWED ON PREMISES INSIDE OR OUTSIDE OF THE VEHICLE.
2. QUIET TIME IS FROM 11PM TO 8AM. No generators loud partying or music or other noise which is disturbing to other campers.
3. Outdoor cooking and campfires are not allowed.
4. You are responsible for supervising your children at all times.
5. No pets allowed.
6. A 16-foot-wide bay space is allowed. Allow four feet between you and your neighbor. Only extend awnings four feet.
7. Park behind the building or in the lot near the loading dock.
8. Permit must be visible on front dash

1. It is understood that camping in the _____ parking lot is a voluntary act. It is possible injuries may occur. Releasees defined in the paragraph below cannot know the abilities, physical and mental condition of releasors' defined in the paragraph below. Releasors are obligated to be aware and responsible for their own physical and mental limitations. It is understood that injury could result from the releasors', releasees', or others acts or omissions.

2. By signing below, I voluntarily, on behalf of myself and my minor children, guests, licensees, and invitees (collectively, referred herein as "releasors") HEREBY RELEASE, WAIVE, RELINQUISH, AND DISCHARGE the Kenai Peninsula School District and the Kenai Peninsula Borough and their officers and employees, officials, agents and volunteers, collectively referred to as "releasees," from all liability to the releasors, including any personal representatives, assigns, heirs, and next of kin, for any and all loss or damage, and any claims or demands, for personal injury, property damage, or wrongful death, arising from or incidental to the use of the _____ parking lot, wherever or however the same may occur and for whatever period said activities may continue, whether caused by the negligence of the releasees, or otherwise.

3. IT IS RELEASOR'S INTENTION BY THIS INSTRUMENT, TO EXEMPT, RELEASE AND HOLD ABSOLUTELY HARMLESS THE RELEASEES FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE, OR DEATH, CAUSED BY NEGLIGENCE THAT MAY OCCUR TO RELEASORS.

I AM ULTIMATELY RESPONSIBLE FOR MY SAFETY OR THE SAFETY OF MY MINOR CHILDREN, INVITEES, LICENSEES AND GUESTS AND BY SIGNING THIS AGREEMENT I ACKNOWLEDGE THAT IF ANYONE IS HURT OR KILLED OR PROPERTY IS DAMAGED WHILE CAMPING AT THE _____ PARKING LOT I MAY BE FOUND BY A COURT OF LAW TO HAVE WAIVED MY RIGHT TO A LAWSUIT OR CLAIM OF ANY TYPE AGAINST RELEASEES. I HAVE READ AND UNDERSTAND THE RELEASE AND AGREE TO BE BOUND BY ITS TERMS.
